Your Board of Directors invite you to the 36th Annual Spring Meeting of the Southeastern Claims Executive Association.


The location this year is a beautiful setting. We are returning to Fort Lauderdale to continue our plan of alternating between the coasts and central Florida.

A splendid educational and social program has been arranged for your enjoyment and to present some of the current problems that need your input and concern.

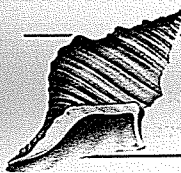
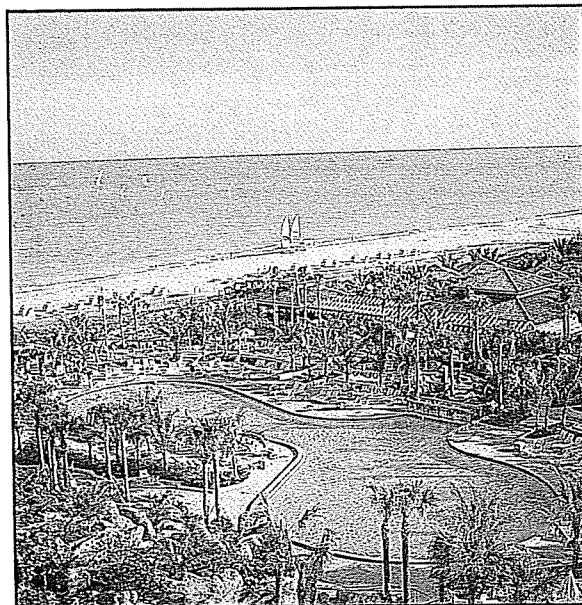
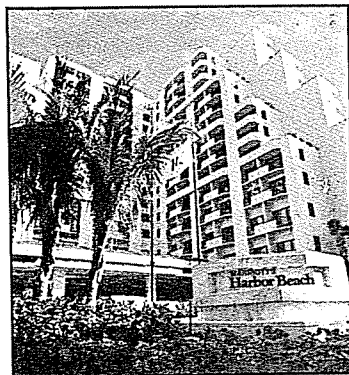
